Good morning,

Thank you for getting to back to me with the information regarding your client's primary school.

When we receive these cases, we check both our paper and electronic archives and unfortunately, I have not been able to locate any information regarding Ms Reid.

I then consulted our senior archivist in the hope that she could locate the information. Unfortunately, the records that we hold for Rosedene are sparse for the period of time you are seeking and stop in March 1958. My colleague then looked at the school register for Central Primary School which is where most Rosedene pupils attended. It was then that I was asked to get back in touch to confirm your client's primary school.

I then went back to my colleague who has provided the following:

"We hold an admission register for St Joseph's from 1956-1974 (Ref: CI/5/3/155f). Maureen was not in the index, so I checked the register under the name, date of birth, parent/guardian and address columns from 1958-1970 but no sign of Maureen. There were a few children in the register from Rosedene with parent/guardian given as The Matron, so Rosedene children went to St Josesph's. As St Joseph's is a Roman Catholic school, I also checked an admission register we hold for the Convent Roman Catholic School from 1935-1965 (Ref: CI/5/3/24d) but again no mention of Maureen."

I realise that this is frustrating and not the outcome that any of us hoped for.

I also realise based on your last email that getting any further information may prove challenging. Is there any other possible avenues we could explore?
