How to complete this section

My time at The Dale was extremely difficult. The staff treated me badly, and the environment felt unsafe from the beginning. I ran away often because I couldn't cope with being there. It felt like the only way I could escape the situation.

One incident that stands out was when a woman came into the unit and a staff member dragged me into the showers. I was around eleven years old. They beat me and turned the showers on while I was inside. It was frightening and humiliating, and it left me feeling completely powerless. This wasn't an isolated event. The staff beat me on several occasions, and I lived in constant fear of what might happen next.

There were also staff members who behaved inappropriately with me and with other children. Their behaviour made me uncomfortable, and I didn't feel safe around them. One staff member crossed a serious boundary. I ended up sharing a bed with him, and he sexually assaulted me and made me do things I didn't understand at the time. It was a deeply traumatic experience.

All of these experiences have had a lasting effect on my mental health. The physical abuse, the emotional harm, and the sexual assault have stayed with me throughout my life. The Dale was supposed to be a place where I was cared for, but instead it became another source of trauma that I am still trying to process.

During my time there, I remember how much I hated it. I ran away because I couldn't cope with how I was being treated. When the police brought me back, the man in charge wanted to hit me with a belt. I stood up to him and told him that was all he could hit me with now, and after that he completely lost control. He beat me badly, hitting me in the face, punching me, and attacking me in ways that left me terrified. I was still just a young person, and there was nothing I could do to protect myself.

After the beating, they locked me in a small cell for ten days. I was kept isolated, with barely anything to eat except milk and pieces of bread with jam. The conditions were horrible, and the loneliness made it even worse. I felt trapped, frightened, and completely forgotten about.

That experience has stayed with me. The violence, the fear, and the way I was treated have had a lasting impact on my mental health. Looking back, it's hard to believe that anyone could treat a child that way, and it's something I still carry with me today.

During my time at Dr Guthrie's, everything was awful. I suffered a lot of physical abuse, and there was one occasion where I was raped by a bully at the school. I tried to speak to the staff about what had happened, but they didn't want to know. They did nothing to help me or protect me. Instead of supporting me, the staff themselves used to beat me on a daily basis. I felt completely alone, scared, and unheard.

The impact on my mental health was severe. I was so distressed and overwhelmed by what I was going through that I ran away multiple times. I was desperate to escape the abuse. At one point, I was in such a bad place mentally that I even set fire to one of the buildings. That shows just how much the situation had pushed me beyond my limits and how unsafe and unsupported I felt.

Looking back, the physical abuse, the sexual assault, and the complete lack of help from the adults who were supposed to protect me have had one of the worst effects on my mental health. I was a child trying to survive in an environment where nobody listened and nobody cared. The trauma from Dr Guthrie's has stayed with me throughout my life, and it is something I am still trying to cope with today.

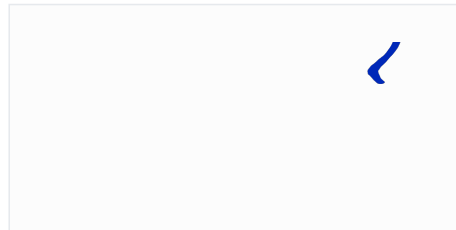
