Your statement for Care setting 1 continued

I was very young when I was placed in and out of care, and I eventually ended up in this placement, which is where the abuse began. From the moment I arrived, I was treated horribly by the staff. They spoke to me and treated me like I was an animal. They would call me names, degrade me, and make me feel worthless.

As punishment, I was made to sit on a chair facing a wall for long periods of time, sometimes all day, without being allowed to eat. This was extremely distressing and isolating, especially at such a young age. I felt completely alone and powerless.

The staff were physically abusive towards me. I was restrained frequently, and these restraints were forceful and painful. They would sit on me in a way that took my breath away and caused me significant physical pain. On some occasions, there would be multiple staff members involved — up to four of them — holding me down. I remember being strangled and placed in choke holds, which left me terrified and struggling to breathe. They would also bend my arms and legs back in ways that caused pain and discomfort.

I was often kept secluded and isolated from others. Although I was provided with food, it was often cold and stale, and I did not feel properly cared for. Family visits were stopped, which made me feel even more alone and abandoned.

I was in this placement for periods of around six weeks at a time and was repeatedly moved in and out, including being sent on respite placements and then brought back. This constant movement meant I was repeatedly returned to the same abusive environment, which made it impossible for me to feel safe or settled anywhere.

During this time, I struggled significantly with my education, as well as my mental and physical health. I began to experience panic attacks, and I developed severe anxiety and PTSD as a result of what I went through in this placement.

Looking back, I believe this was the beginning of the abuse that went on to shape my life. The way I was treated here changed me as a person. It has had a lasting and damaging impact on my mental health, my ability to trust others, and my overall wellbeing. I continue to suffer from the effects of this trauma to this day.

Your statement for Care setting 2 continued

When I arrived here, there was no empathy or understanding shown towards me. I felt like no one cared about me. All of the staff were rough in the way they treated us, both physically and emotionally. From the beginning, I felt unsafe and unsupported.

The placement was set up so that there was a unit where we lived, and we were often secluded and locked away for long periods of time. From there, we would be sent across to the school. Even at school, I was not safe. Staff would come into the school and drag us by our hair or arms into another room. We would be made to sit there all day without food or drink, and at times we had to beg for basic things. This was extremely degrading and distressing.

If we showed any resistance or tried to stand up for ourselves, we would be beaten. There were staff members who would physically assault us, leaving heavy bruising while claiming they were using force. The level of violence used against us was severe and completely inappropriate.

I was also subjected to constant verbal abuse. Staff would call me names, including calling me "dumb," and they would single me out regularly. They would refer to us as "wee bastards" and "idiots," and we had no choice but to accept this treatment. I was also targeted because I had no family, and this was used against me to humiliate and upset me.

The physical restraints used on me were extremely painful. After being restrained, I would often be left in so much pain that I could not move properly for days. This added to the trauma I was already experiencing and made me fearful of any interaction with staff.

This environment was both physically and mentally exhausting. I was suffering badly with my mental health during this time. I experienced severe anxiety, and those feelings have stayed with me ever since. As a result of what I went through, I now suffer from PTSD, depression, and ongoing anxiety.

I also struggle with anger and controlling my emotions. I find it very difficult to cope with everyday situations, and this has affected my ability to work and function in normal life. I feel that what I experienced has ruined my life in many ways, as I struggle to cope in the real world and manage my mental health.

I was in this placement for around three years, and during that time the abuse continued. Eventually, I was moved to St John's, but by that point the damage had already been done.

Looking back, I feel that I was completely failed. I was not protected, not supported, and not cared for. The impact of this experience has been long-lasting and continues to affect every aspect of my life today.
